

## Member Benefits

As a member of FaithLife Financial, you are eligible for the following benefits:

**Charitable Giving Benefit** – When you purchase a new, permanent life insurance plan, we provide a gift of up to \$5,000 (2% of the permanent life insurance face amount) to the charity of your choice, upon your death, at no additional cost to you.

**Wills/Power of Attorney Benefit** – When you employ the services of a legal professional to draft or update a personal will or power of attorney, you can apply for reimbursement up to \$75 (available once every five years).

**Little Angel Benefit** – If your baby dies within 60 days of birth, you are eligible to receive \$2,500. One parent must have been a FaithLife Financial member.

**Orphan Benefit** – Juvenile members where both parents have died can receive \$1,000 a month until age 19 (or age 23 if still a full-time student). One parent must have been a FaithLife Financial member.

**Scholarships** – Scholarships are awarded annually to members enrolled in a full-time university or college program. You can apply for a one-time scholarship of \$2,000 for a university program or \$750 for a college program.

**Grief Book** – A comforting book, *Winter Grief, Summer Grace: Returning to Life After a Loved One Dies*, by James E. Miller, is provided at no charge to the beneficiaries of death claims.

### What is a Chapter?

A Chapter is a group of FaithLife Financial members who join together to support fundraising and fellowship events in a Christian congregation or organization. Associate members are not eligible for Chapter programs.

**Forming a Chapter is simple:** five or more FaithLife Financial members worshipping or working in the same organization can apply for Chapter status and become eligible to receive matching grants for their fundraising efforts.

**FaithLife Financial has more than 360 Chapters across Canada!**

### Chapter Grants

- Chapters are eligible for Matching Grants of up to \$1,500 annually.\*
- Chapters can support any project that is important to their congregation or organization. For example, you can help your congregation raise funds to renovate your church, assist a community member who is ill, or support mission work.\*
- Chapters that have fifteen or more FaithLife Financial members can apply for a Fellowship Grant each year to be used toward fellowship activities.\*
- From time to time, FaithLife Financial responds to an international disaster with a special relief program.

These Special Program Grants are communicated directly to Chapters for their consideration to participate.

### Chapter Programs

**Faith Affirmation Recognition** – FaithLife Financial provides a special memento to members who are formally affirming their faith commitment through confirmation or adult baptism.

**Ordination Celebration Program\*** – Chapters can apply for a \$1,000 gift to recognize their full time pastor's 10<sup>th</sup>, 20<sup>th</sup>, 30<sup>th</sup> or 40<sup>th</sup> anniversary of ordination. The pastor must be a FaithLife Financial member and use the gift for wellness or education. This benefit is available one time only.

### Congregational & Community Benefits

**Church Mortgage Program** – If your congregation needs a church mortgage, it may be eligible for special rates and terms with FaithLife Financial. Our interest rates are often lower than market rates, and are reviewed annually for potential reductions.

**Pre-authorized Offering Program (POP)** – POP is a low-cost direct debit service that allows people to support their church through a convenient automatic monthly bank account withdrawal.

**Educational enrichment** – FaithLife Financial can present informative seminars on important financial issues, such as money management, retirement planning and stewardship.

### National & International Outreach

**Outreach** – When crisis strikes, FaithLife Financial members put their faith into action and respond to the call for help. Through the years, members have raised money for families devastated by fires, floods, tsunamis and earthquakes. FaithLife Financial also supports a variety of humanitarian causes, such as Canadian Lutheran World Relief, World Vision, Myanmar, Pakistan and Haiti.

**Special event support** – FaithLife Financial supports national ministries and events that enrich Christian life, such as Promise Keepers and Girls Night Out. We consider sponsorship for worship conferences and inspirational Christian fellowship events as well.
